Sir,

In pursuance of the above UGC letter and the letter of Government of Odisha under reference, the Biju Patnaik University of Technology, Odisha, Rourkela has been pleased to accord approval on conferment of academic autonomy in favour of Srusti Academy of Management, Bhubaneswar, 38/1 Chandaka Industrial Estate, Near Infocity, Po- Patia, Bhubaneswar, Dist-Khurda – 751024 under Section 5(iii) of the BPUT Act, 2002.

The grant of academic autonomy shall be subject to the following terms and conditions/guidelines.

- The Autonomy shall be operative for ten years from the Academic Session 2021-22 to 2030-31 or until further orders whichever is earlier subject to the conditions stipulated in the aforesaid letter of the UGC, India.
- The autonomy is granted to Srusti Academy of Management, Bhubaneswar, 38/1 Chandaka Industrial Estate, Near Infocity, Po- Patia, Bhubaneswar, Dist-Khurda – 751024 as conferred by UGC, New Delhi vide file No. F.22-1/2017(AC) dated 07-09-2021.
- Admission of students to the PG programmes offered by the college shall be in conformity with the provisions of 'The Orissa Professional Educational Institution (Regulation of Admission and Fixation of Fee) Act', 2007 as amended from time to time.
- 4. The college shall admit students in respect of the courses for which Academic Autonomy is conferred against the syllabus, course-content etc. to be submitted by the college. The method of



conducting examination, evaluation, award of grades would be primarily guided by the provisions of the Academic Regulations of the University.

- 5. The college shall have the power to make its own rules, regulations of by-laws in consonance with the UGC Guidelines for Autonomous Colleges and Biju Patnaik University of Technology and the laws framed there under for the purpose of fulfilling the objectives for conferring the autonomy status.
- 6. The college shall have a Governing Body, Academic Council, Finance Committee, Board of Studies and other committees and Statutory bodies as per requirements of UGC for autonomous colleges with adequate number of University representatives to ensure the quality and standards of courses for the subjects and shall be comparable to the quality standards prescribed by the University and the UGC Guidelines for Autonomous Colleges.
- 7. The University shall approve the results of approved courses and confer degree to the successful candidates as per UGC Guidelines for Autonomous Colleges subject to prior approval of the results after each semester.
- 8. The Board of Management of the University shall have power to revoke the autonomy at any time after scrutiny and after due notice of such intention to the college before the expiry of such period granted from time to time, in case of deteriorating standards or for any other cause as deemed fit.
- 9. The Board of Management of the University shall have power to monitor the functioning of the college through periodic review. It will have the power for inspection or cause inspection to be made by such person or persons to the college and its buildings, workshops etc. and would also have the right to scrutinize the process of teaching, examination and other works conducted or done by the college. The Board would also have the power to make such inquiry and issue notice to the Principal on the academic matter of the college.
- 10. Notwithstanding anything stated above, conferment of autonomous status to Srusti Academy of Management, Bhubaneswar, 38/1 Chandaka Industrial Estate, Near Infocity, Po- Patia, Bhubaneswar, Dist-Khurda 751024 shall however be subject to fulfilment of such standing orders, rules, regulations, guidelines and directions issued from time to time by the Government/UGC/AICTE and the University and as amended from time to time.

This is with reference to the proposal submitted by Srusti Academy of Management, Bhubneswar, 38/1, Chandaka Industrial Estate, Near Infocity, PO Patia-751 024 Odisha affiliated to Biju Patnaik University of Technology, Rourkela under the UGC Scheme for Autonomous Colleges.

As per the decision of the Standing Committee constituted by University Grants Commission, in its meeting held on 01.09.2021, the Competent Authority has decided to grant autonomous status to Srusti Academy of Management, Bhubneswar, 38/1, Chandaka Industrial Estate, Near Infocity, PO Patia-751 024 Odisha affiliated to Biju Patnaik University of Technology, Rourkela for a period of Ten (10) years from the session 2021-2022 to 2030-2031 as per provisions of Clause 3.13 and Clause 6.4 (i) of UGC Regulations dated 12.02.2018.
